AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 82.07 RELATING TO PARKING METERS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 82.07 to read as follows:

SEC. 82.07 PARKING VIOLATIONS

## (a) Enforcement

Every police officer charged with the enforcement of the provisions of Chapter VIII of this Code relating to illegal parking, the provisions of the California Vehicle Code, and the other laws of the State of California applicable to parking violations within the City of San Diego, shall have the duty, when any vehicle is illegally parked, to issue written notice of violation thereof stating the State vehicle license number, make of such vehicle, the time and date of such illegal parking, meter number, street location, and a reference to the appropriate section of the Code and fixing a time and place for appearance by the registered owner to answer said notice. Such notice shall be attached to said vehicle either on the steering post or front door handle thereof or in such other conspicuous place upon the vehicle as

to be easily observed by the person in charge of such yehicle upon his return thereto.

## (b) Fees

For the purpose of regulating the use of streets and traffic thereon and as a deterrent to illegal parking, the following fees are established:

# (c) Failure to Pay

Failure to pay the appropriate fee as provided herein or failure to request a court appearance date to contest the violation will result in legal proceedings being instituted in the Municipal Court of the San Diego Judicial District against the registered owner for violation of the appropriate Code section in accordance with the provisions of Section 41102 of the Vehicle Code of the State of California.
