AN ORDINANCE AMENDING ORDINANCE NO. 12397 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 764187, AS ADOPTED AND AMENDED THEREIN, BY ADDING 12.0 POSITIONS TO THE CITY TREASURER DEPARTMENT (07.50) FOR THE PARKING CITATION PROGRAM AND 4.0 POSITIONS TO THE DATA PROCESSING DEPARTMENT (14.40) FOR THE REMAINDER OF THE FISCAL YEAR (BEGINNING MARCH 1, 1979); AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$96,013 FROM THE UNALLOCATED RESERVE TO THE CITY TREASURER DEPARTMENT (\$76,701) AND TO THE DATA PROCESSING DEPARTMENT (\$19,312), FOR THE PROCESSING OF PARKING CITATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Ordinance No. 12397 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 764187, as adopted and amended therein, by adding 12.0 positions to the City Treasurer Department (07.50) for the processing of Parking Citations, as follows: one (1) Administrative Aide II, six (6) Intermediate Clerks, two (2) Intermediate Typists, one (1) Junior Clerk, one (1) Junior Typist and one (1) Senior Clerk; and 4.0 positions to Data Processing Department (14.40), as follows: four (4) Data

Entry Operators, for the remainder of Fiscal Year (Beginning March 1, 1979).

Section 2. That the City Auditor and Comptroller be and he is hereby authorized and directed to transfer the sum of \$96,013 from the Unallocated Reserve to the City Treasurer Department (\$76,701) and to the Date Processing Department (\$19,312), in accordance with the proposed budgetary allocation attached hereto as Attachment A.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.

The Fiscal 1979 July Appropriation Ordinance is amended to add 12 positions to the City Treasurer Department (07.50) for the processing of Parking Citations, as follows: one (1) Administrative Aide II, six (6) Intermediate Clerks, two (2) Intermediate Typists, one (1) Junior Clerk, one (1) Junior Typist and one (1) Senior Clerk; and 4.0 positions to Data Processing Department (14.40), as follows: four (4) Data Entry Operators, for the remainder of Fiscal Year (Beginning March 1, 1979).

The Appropriation Ordinance is further amended to authorize the transfer of \$96,013 from the Unallocated Reserve to the Treasurer's Department (\$76,701) and to Data Processing Department (\$19,312) to support the Parking Citation Program.
