AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 2, DIVISION 5 OF THE MUNICIPAL CODE BY AMENDING SECTION 62.0501 RELATING TO STREET BENCHES AND RESCINDING SECTION 62.0502.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 5 be amended by amending Section 62.0501 to read as follows:

Sec. 62.0501 STREET BENCHES, CONDITIONS AND REGULATIONS

No person shall place or cause to be placed, any bench, seat, or chair in, over, along or upon any public street or City-owned property without. first obtaining a written permit from the City Manager and without first complying with the terms and conditions of any such permit. All such permits shall contain such terms and conditions as deemed necessary or desirable by the City Manager to protect the public health, safety and general welfare. All such permits shall allow the City Manager, at his discretion, to revoke the permit as to specific benches and their location. Any such permit or agreement for the placing of more than 20 of such benches, seats or chairs upon any public street must be approved by the City Council and shall contain such terms and conditions as the City Council deems necessary to protect the public health, safety and general welfare.

Section 2. That Section 62.0502 is hereby rescinded in its entirety.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
