BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 2, Division 8 of the San Diego Municipal Code be and it is hereby amended by amending Section 62.0801 to read as follows:

SEC. 62.0801 STREET CLOSING AND EASEMENT ABANDONMENT FEES
