AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 5,
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 85.25 RELATING TO OVERLOAD MOVING--
PERMIT FEES.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter VIII, Article 5, of the San Diego
Municipal Code be amended by amending the following section to
read as follows:

SEC. 85.25 OVERLOAD MOVING--PERMIT FEES

Transportation permit fees shall be established
by the City Manager and collected by the City Engineer.
The fees established shall be filed in the City Clerk's
office and included in the City's "Ratebook of Fees
and Charges." The fees shall be reviewed annually by
the City Manager and revised at that time to assure
that the fees accurately represent the City cost.

Governmental agencies, including the State of
California and any of its political subdivisions, shall
make application for permits under the provisions of
this Article and shall be issued a no-fee permit in
accordance with the provisions herein. A contractor
working for a governmental agency shall not be con-
sidered to be acting on behalf of that governmental
agency and shall not be exempt from the payment of fees.

An extension of the effective date or an amendment to a single-move permit may be made without payment of additional fees if approved by the City Engineer, provided that the request for such extension or amendment is received before the expiration of the permit.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
