BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter II, Article 9, of the San Diego
Municipal Code be and the same is hereby amended by amending
Section 29.0106(d) to read as follows:

SEC. 29.0106 MUNICIPAL ADVOCATE--REPORT REQUIRED

(d) In the event the municipal advocate expends
less than required to be reported by paragraph (c)
above during any one quarter, he shall not be required
to file an activity report.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.

SEC. 29.0109 MUNICIPAL ADVOCATE - REPORT REQUIRED

4. In the event the municipal advocate expends less than required to be reported by paragraph 1c) above during any one calendar year, he shall not be required to file an activity report.

Section 2. This ordinance shall take effect and be in force on the sixtieth day from and after its passage.
