AN ORDINANCE SETTING ASIDE AND DEDICATING **MAR 5 1979**
CERTAIN LANDS IN THE CITY OF SAN DIEGO,
CALIFORNIA, FOR A PUBLIC PARK AND NAMING
SAID PARK "MISSION BAY PARK."

BE IT ORDAINED, by the Council of The City of San
Diego, as follows:


Section 1. That portion of Pueblo Lot 262 of the
Pueblo Lands and those portions of said Pueblo Lot 262 and
of Valley Gardens, Bayside and City Gardens, which are more
particularly described in Attachment A hereto which is by
this reference incorporated herein, is hereby set aside
and dedicated in perpetuity for park and recreational purposes.

Section 2. That the hereinafter described real property
be and the same is hereby named MISSION BAY PARK.

Section 3. That the City Clerk of said City be and he
is hereby authorized and directed to file for record in the
office of the San Diego County Recorder a certified copy of
this ordinance.

Section 4. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
