AN ORDINANCE INCORPORATING LOTS 3 THROUGH 10, BLOCK 11, ROSEVILLE, MAP NO. 305 (APPROXIMATELY 40,000 SQUARE FEET), LOCATED ON THE NORTHEAST SIDE OF ADDISON STREET BETWEEN SCOTT STREET AND SHAFTER STREET, IN THE PENINSULA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL GODE, AND REPEALING ORDINANCE NO. 32 (NEW SERIES), ADOPTED SEPTEMBER 6, 1932, AND ORDINANCE NO. 7443 (NEW SERIES), ADOPTED MAY 23, 1957, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 3 through 10, Block 11, Roseville,
Map No. 305 (approximately 40,000 square feet), located on the
northeast side of Addison Street between Scott Street and Shafter
Street, in the Peninsula Community Plan Area, in the City of San
Diego, California, within the boundary of the district designated
"CA" on Zone Map Drawing No. B-3184, be, and it is hereby incorporated
into CA Zone, as such zone is described and defined by Section 101.0428.1
of the San Diego Municipal Code.

Section 2. That Ordinance No. 32 (New Series), adopted September 6, 1932, and Ordinance No. 7443 (New Series), adopted May 23, 1957, of the ordinances of the City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
