AN ORDINANCE AMENDING ORDINANCE NO. 12397 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMEND-ING DOCUMENT NO. 764187, AS ADOPTED AND AMENDED THEREIN, BY TRANSFERRING 11.00 POSI-TIONS FROM THE PROJECT DEVELOPMENT DIVISION OF THE ENGINEERING AND DEVELOPMENT DEPART-MENT (39.00) TO THE PROPERTY DEPARTMENT (10.00); AND AUTHORIZING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$305,551 FROM THE GENERAL FUND, PROJECT DEVELOPMENT DIVISION OF ENGINEERING AND DEVELOPMENT DEPARTMENT (39.00) TO PROPERTY DEPARTMENT (10.00).

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12397 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 764187, as adopted and amended therein, by transferring 11.00 positions from the Project Development Division of the Engineering and Development Department (39.00) to the Property Department (10.00).

Section 2. That the City Auditor and Comptroller be and he is hereby authorized and directed to transfer the sum of \$305,551 from the General Fund, Project Development Division

of the Engineering and Development Department (39.00) to the Property Department (10.00), in accordance with the proposed budgetary allocation attached hereto as Attachment A.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
