this ordinance.

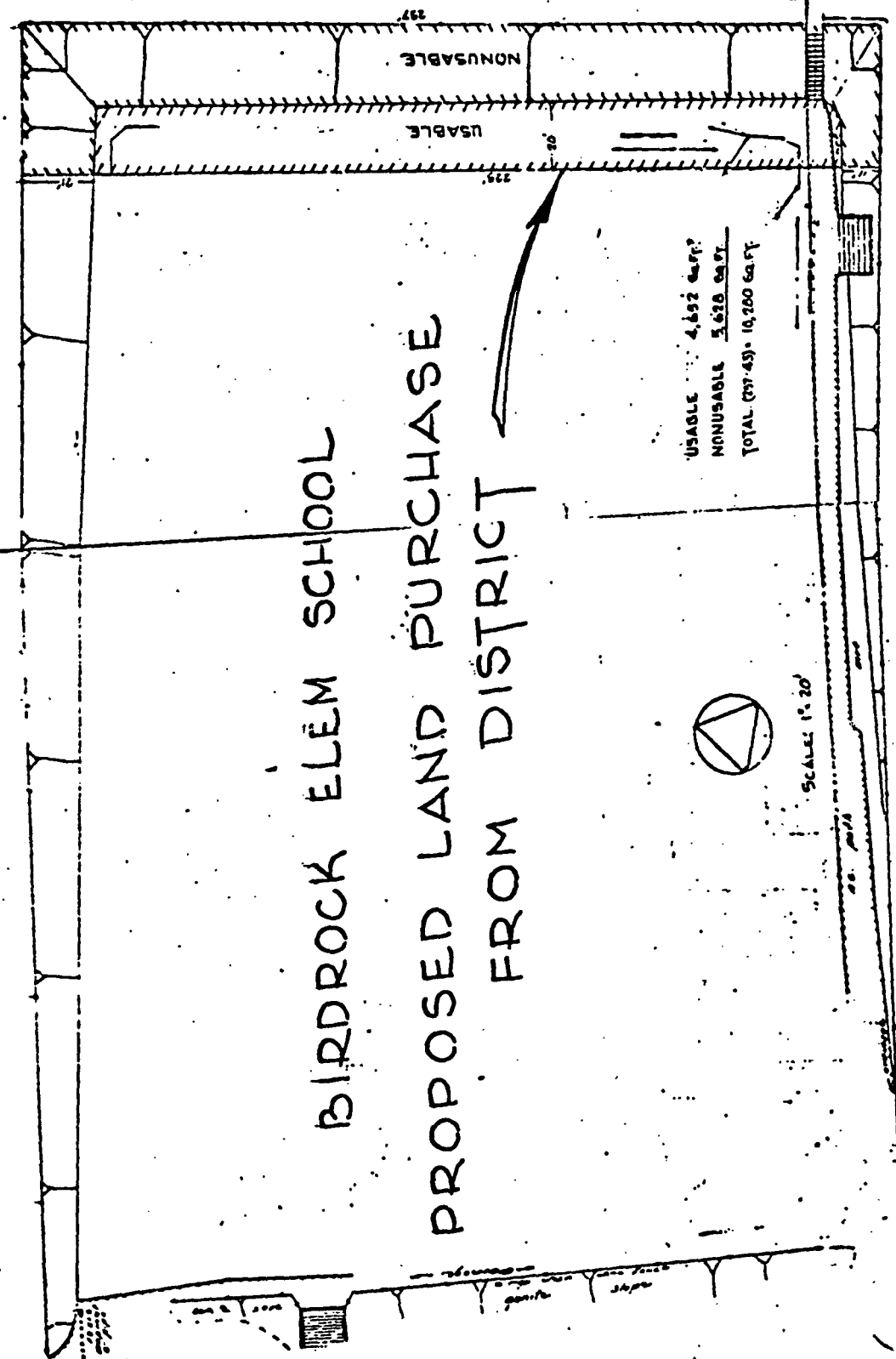
Section 3. This ordinance shall take effect and be in
