AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 2, APR 24 1979 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 82.07 RELATING TO PARKING METERS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending Section 82.07 to read as follows:

SEC. 82.07 PARKING VIOLATIONS

(a) Enforcement
