AN ORDINANCE INCORPORATING A PORTION OF PUEBLO LOT 1258 (APPROXIMATELY 8.3 ACRES) GENERALLY LOCATED EAST OF FAY AVENUE BETWEEN NAUTILUS STREET AND VINCENTE WAY IN THE LA JOLLA COMMUNITY PLAN AREA IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-8 ZONE AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8211 (NEW SERIES), ADOPTED DECEMBER 10, 1959, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. That Ordinance No. 8211 (New Series), adopted December 12, 1959, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the

provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
