AN ORDINANCE INCORPORATING A PORTION OF LOT 10
AND All OF LOTS 11 THROUGH 24, BLOCK 74, CITY
HEIGHTS, MAP NO. 1007 (APPROXIMATELY 1.08 ACRES),
LOCATED ON THE NORTH SIDE OF LANDIS AVENUE BETWEEN
43RD STREET AND FAIRMOUNT AVENUE, IN THE MID-CITY
COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO,
CALIFORNIA, INTO C ZONE, AS DEFINED BY SECTION
101.0432.1 OF THE SAN DIEGO MUNICIPAL CODE, AND
REPEALING ORDINANCE NO. 11606 (NEW SERIES), ADOPTED
MAY 22, 1975, OF THE ORDINANCES OF THE CITY OF SAN
DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The city of San Diego, as follows:

Section 1. That a portion of Lot 10 and 11 of Lots 11 through 24, Block 74, City Heights, Map No. 1007 (approximately 1.08 acres), located on the north side of Landis Avenue between 43rd Street and Fairmount Avenue in the Mid-City Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "C" on Zone Map Drawing No. B-3209, be, and it is hereby incorporated into C Zone, as such zone is described and defined by Section 101.0432.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11606 (New Series), adopted May 22, 1975, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
