AN ORDINANCE AMENDING ORDINANCE NO. 12397 (NEW SERIES), AS AMENDED, ENTITLED " AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 764187, AS ADOPTED AND AMENDED THEREIN, BY APPROPRIATING THE SUM OF \$1,000,000 FROM THE GENERAL FUND UNAPPROPRIATED FUND BALANCE TO THE GENERAL FUND UNALLOCATED RESERVE; AUTHORIZING AND DIRECTING THE CITY AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$1,000,000 FROM THE GENERAL FUND UNALLOCATED RESERVE TO FUND 2824 (CONTRIBUTIONS TO REDEVELOPMENT AGENCY FUND); AUTHORIZING AND DIRECTING THE CITY AUDITOR AND COMPTROLLER TO MAKE A PAYMENT OF \$1,000,000 FROM FUND 2824 (CONTRIBUTIONS TO REDEVELOPMENT AGENCY FUND), TO THE REDEVELOPMENT AGENCY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12397 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 764187, as adopted and amended therein, by appropriating the sum of \$1,000,000 from the General Fund Unappropriated Fund Balance to the General Fund Unallocated Reserve.

Section 2. That the City Auditor and Comptroller be and he is hereby authorized and directed to transfer the sum of \$1,000,000 from the General Fund Unallocated Reserve to Fund 2824 (Contributions to Redevelopment Agency Fund).

Section 3. That the City Auditor and Comptroller be and he is hereby authorized and directed to make a payment of \$1,000,000 from Fund 2824 (Contributions to Redevelopment Agency Fund), to the Redevelopment Agency.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.
