AN ORDINANCE INCORPORATING LOTS 460, 461 AND 462, MIRA MESA VERDE NO. 31, MAP NO. 7096 (APPROXIMATELY 14.76 ACRES), LOCATED NORTH AND SOUTH OF CAPRICORN WAY BETWEEN CAMINO RUIZ AND GANESTA ROAD, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10341 (NEW SERIES), ADOPTED JULY 21, 1970, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 460, 461 and 462, Mira Mesa Verde No. 31, Map No. 7096 (approximately 14.76 acres), located north and south of Capricorn Way between Camino Ruiz and Ganesta Road, in the Mira Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. B-3202, be, and it is hereby incorporated into R-2 Zone as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10341 (New Series), adopted July 21, 1970, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
