AN ORDINANCE AMENDING ORDINANCE NO. 12397 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY RESCINDING SECTION 15 ENTITLED, "SPACE THEATRE CONCESSION REVOLVING FUND."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:
