AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST
OF THE CITY BOUNDARY AND WEST OF THE EASTERLY BOUNDARY
OF SECTIONS 6 AND 7, TOWNSHIP 14 SOUTH, RANGE 2 WEST,
S.B.B.M. AND BETWEEN THE NORTHERLY BOUNDARIES OF
SECTIONS 1 AND 2, TOWNSHIP 14 SOUTH, RANGE 3 WEST,
S.B.B.M. AND SECTIONS 5 AND 6, TOWNSHIP 14 SOUTH, RANGE
2 WEST, S.B.B.M. ON THE NORTH AND DEER CANYON ON THE
SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR
(HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION
101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those hillsides east of the City boundary and west of the easterly boundary of Sections 6 and 7, Township 14 South, Range 2 West, S.B.B.M. and between the northerly boundaries of Sections 1 and 2, Township 14 South, Range 3 West, S.B.B.M. and Sections 5 and 6, Township 14 South, Range 2 West, S.B.B.M. on the north and Deer Canyon on the south, in the City of San Diego, California, within the boundary of the district designated "HR Overlay Zone" on Zone Map Drawing No. C-615, filed in the office of the City Clerk as Document No. 765922, be, and they are hereby incorporated into the HR Overlay Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be inforce on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
