AN ORDINANCE AMENDING ORDINANCE NO. 12397 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR, "BY AMENDING DOCUMENT NO. 764187, AS ADOPTED AND AMENDED THEREIN, BY APPROPRIATING THE SUM OF \$1,826,000 FROM THE GENERAL FUND UNAPPROPRIATED REVENUE TO THE GENERAL FUND UNALLOCATED RESERVE; ALLOCATING THE SUM OF \$1,826,000 FOR THE PURPOSE OF LAND ACQUISITION IN THE HORTON PLAZA PROJECT AREA.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12397 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1978-79 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 764187, as adopted and amended therein, by appropriating the sum of \$1,826,000 from the General Fund Unappropriated Revenue to the General Fund Unallocated Reserve.

Section 2. That the sum of \$1,826,000 from the General Fund Unallocated Reserve be allocated for the purpose of acquiring land in the Horton Plaza Project Area.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.
