AN ORDINANCE INCORPORATING A PORTION OF LOTS 131, 132, 133 AND 135, NAVAJO PARK UNIT NO. 2, MAP NO. 8999 AND A PORTION OF LOT 70, RANCHO MISSION OF SAN DIEGO, S.C.C. NO. 15191 (APPROXIMATELY 39,798 SQUARE FEET), LOCATED ON THE NORTHWEST CORNER OF NAVAJO ROAD AND GOLFCREST DRIVE, IN THE NAVAJO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CO ZONE AS DEFINED BY SECTION 101.0423 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10893 (NEW SERIES), ADOPTED AUGUST 22, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That in the event that, within two years . . Section 1. of the effective date of this ordinance, a portion of Lots 131, 132, 133 and 135, Navajo Park Unit No. 2, Map No. 899 and a portion of Lot 70, Rancho Mission of San Diego, S.C.C. No. 15191 (approximately 39,798 square feet), located on the northwest corner of Navajo Road and Golfcrest Drive, in the Navajo Community Plan area, in The City of San Diego, California, within the boundary of the district designated "CO" on Zone Map Drawing No. B-3191, is the subject of which a parcel map or maps is submitted to the City and thereafter recorded, and provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0423 of the San Diego Municipal Code shall attach and become applicable to said land, and said land shall be incorporated into CO Zone, as described and defined by Section 101.0423, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3191, filed in the office of the City Clerk as Document

No. 766073. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 10893 (New Series), adopted August 22, 1972, of the ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
