AN ORDINANCE AMENDING CHAPTER III, ARTICLE 1, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 31.0391; AND AMENDING CHAPTER III, ARTICLE 3, DIVISION 32, OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTIONS 33.3201, 33.3202, 33.3203 and 33.3206 RELATING TO SWAP MEETS/SWAP LOTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 1, Division 3, of the San Diego Municipal Code be and the same is hereby amended by amending Section 31.0391 to read as follows:

SEC. 31.0391 LICENSE FEE--SWAP MEET/SWAP LOT

Every person except as provided below who operates a swap meet or swap lot as defined in Section 33.3200 of this Code shall pay daily a license fee of twenty-five dollars (\$25) and a daily license fee of fifty cents (\$.50) for each seller in excess of one hundred sellers in attendance.

Every person who operates a swap meet or swap lot primarily for the purpose of permitting members of the public at large to offer for sale or sell used motor vehicles, trailers, or boats which are registered with the California Department of Motor Vehicles shall pay a license fee of two hundred fifty dollars (\$250) per year.

Section 2. That Chapter III, Article 3, Division 32, of the San Diego Municipal Code be and the same is hereby amended by repealing Sections 33.3201, 33.3202, 33.3203, and 33.3206 as follows:

SEC. 33.3201 REPORTS REQUIRED BY SELLER

SEC. 33.3202 REPORTS REQUIRED BY OWNER OR OPERATOR

SEC. 33.3203 REPORT OF SALE

SEC. 33.3206 HOURS OF OPERATION.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

SEC. 31.0391 LICENSE FEE--SWAP MEET/SWAP LOT

Every person except as provided below who operates a swap meet or swap lot as defined in Section 33.3200 of this Code shall pay daily a license fee of one-hundred-dollars-(\$100) twenty-five dollars (\$25) and a daily license fee of one-dollar-(\$1) fifty cents (\$.50) for each seller in excess of one hundred sellers in attendance.

Every person who operates a swap meet or swap lot: primarily for the purpose of permitting members of the public at large to offer for sale or sell used motor vehicles, trailers, or boats which are registered with the California Department of Motor Vehicles shall pay a license fee of two hundred fifty dollars (\$250) per year.
