

AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 2, JUL 9 1979  
 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
 SECTION 82.07 RELATING TO PARKING VIOLATIONS.

BE IT ORDAINED, by the Council of The City of San Diego,  
 as follows:

Section 1. That Chapter VIII, Article 2, of the San Diego  
 Municipal Code be and the same is hereby amended by amending  
 Section 82.07 to read as follows:

SEC. 82.07 PARKING VIOLATIONS

(a) Enforcement
