AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 19 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.1901, REGARDING A ONE-YEAR EXTENSION OF THE EXPIRATION DATE OF SAID ORDINANCE RELATING TO OFF-PREMISES ADVERTISING DISPLAYS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 19 of the San Diego Municipal Code, be, and it is hereby amended by amending Section 101.1901 to read as follows:

SEC. 101.1901 TIME LIMITATIONS FOR ORDINANCE AND MAINTENANCE OF DISPLAYS.

A. This ordinance shall remain in force until August 17, 1980.

B. [No amendment to this subsection.]

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
