AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 2 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0202 RELATING TO BUILDING PERMITS.

BE IT ORDAINED by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 2 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0202 to read as follows:

SEC. 101.0202 APPROVAL REQUIRED BEFORE ISSUANCE OF PERMIT.

Notwithstanding any other section of this Code to the contrary, the Department of Public Health and the Department of Building Inspection shall not issue any permit for the installation of fixtures or equipment, or for the erection, construction, conversion, establishment, alteration or enlargement of any building, structure, or improvement in any portion of the City until the development plans have been reviewed and conformity to Chapter X of the Municipal Code has been established by either the Planning Department or the Department of Building Inspection, and a stamp of approval of either the Planning Department or the Department of Building Inspection has been obtained by the applicant or owner, and every application for a permit shall state therein the purpose for which the proposed building, structure or improvement is intended to be used.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
