AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY APPROPRIATING THE SUM OF \$1,000,000 GENERAL FUND UNAPPROPRIATED REVENUE TO THE GENERAL FUND UNALLOCATED RESERVE, AND ALLOCATING THE SUM OF \$1,000,000 FROM THE GENERAL FUND UNALLOCATED RESERVE, FOR CONTRIBUTION TO HELP FINANCE THE RECONSTRUCTION OF THE OLD GLOBE THEATRE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 766809 as amended by Document No. 766810, as adopted and amended therein, by appropriating the sum of \$1,000,000 General Fund Unappropriated Revenue to the General Fund Unallocated Reserve.

Section 2. That the sum of \$1,000,000 from General Fund Unallocated Reserve be allocated for contribution to help finance the reconstruction of the Old Globe Theatre.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its adoption.
