AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF THE WESTERLY BOUNDARIES OF SECTIONS 4 AND 9, TOWNSHIP 15 SOUTH, RANGE 2 WEST AND WEST OF THE EASTERLY BOUNDARIES OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 2 WEST AND SECTIONS 1 AND 6, TOWNSHIP 15 SOUTH, RANGE 2 WEST AND BETWEEN POMERADO ROAD ON THE NORTH AND THE SOUTHERLY BOUNDARIES OF SECTIONS 13, 14, 15 AND 16, TOWNSHIP 15 SOUTH, RANGE 2 WEST ON THE SOUTH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:


Section 1. Those hillsides east of the westerly boundaries of Sections 4 and 9, Township 15 South, Range 2 West and west of the easterly boundaries of Section 36, Township 14 South, Range 2 West and Sections 1 and 6, Township 15 South, Range 2 West and between Pomerado Road on the north and the southerly boundaries of Sections 13, 14, 15 and 16, Township 15 South, Range 2 West on the south, in the Elliott Community Area, in the City of San Diego, California, within the boundary of the district designated "HR Overlay Zone" on Zone Map Drawing No. C-630, filed in the office of the City Clerk as Document No. 766258, be, and they are hereby incorporated into the HR Overlay Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this
