AN ORDINANCE INCORPORATING THOSE HILLSIDES EAST OF THE WESTERLY BOUNDARIES OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 2 WEST AND SECTIONS 1, 12 AND 13, TOWNSHIP 15 SOUTH, RANGE 2 WEST AND WEST OF THE SAN DIEGO CITY BOUNDARY, AND BETWEEN THE NORTHERLY BOUNDARIES OF SECTION 36, TOWNSHIP 14 SOUTH, RANGE 2 WEST AND SECTIONS 31, 32 AND 33, TOWNSHIP 14 SOUTH RANGE 1 WEST ON THE NORTH AND THE SOUTHERLY BOUNDARIES OF SECTION 13, TOWNSHIP 15 SOUTH, RANGE 2 WEST AND SECTIONS 17 AND 18, TOWNSHIP 15 SOUTH, RANGE 1 WEST ON THE SOUTH, IN THE ELLIOTT COMMUNITY AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO HR (HILLSIDE REVIEW) OVERLAY ZONE, AS DEFINED BY SECTION 101.0454 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. Those hillsides east of the westerly boundaries of Section 36, Township 14 South, Range 2 West and Sections 1, 12 and 13, Township 15 South, Range 2 West and west of the San Diego City boundary, and between the northerly boundaries of Section 36, Township 14 South, Range 2 West and Sections 31, 32 and 33, Township 14 South Range 1 West on the north and the southerly boundaries of Section 13, Township 15 South, Range 2 West and Sections 17 and 18, Township 15 South, Range 1 West on the south, in the Elliott Community Area, in the City of San Diego, California, within the boundary of the district designated "HR Overlay Zone" on Zone Map Drawing No. C-631, filed in the office of the City Clerk as Document No. 766259, be, and they are hereby incorporated into the HR Overlay Zone, as such zone is described and defined by Section 101.0454 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage,

and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
