AN OFDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 4 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0430.1 REGARDING C-1 ZONE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

101.0430.1 C-1 ZONE SEC.

- D. PROPERTY DEVELOPMENT REGULATIONS (No amendment to subsections 1 through 5)
  - 6. Landscaping.

Prior to the use and occupancy of any premises of 25 feet in width or less, a minimum of two percent of said premises, which shall be visible from an immediate abutting public street right-of-way, shall be suitably landscaped with shrubs, trees, and ornamental ground cover. The minimum landscaping requirement shall increase one-half of one percent for each 25 feet or parcel width, but need not exceed a maximum of five percent. The landscaped area may include planter boxes and potted plants if

said items are approved by the Zoning Administrator. Prior to the issuance of any building permits, a complete landscaping plan shall be submitted to the Zoning Administrator for approval. Substantial conformance shall be determined by the Zoning Administrator who may reduce or waive the landscaping requirement on a discretional basis; said determination shall be subject to appeal in the manner set forth in Chapter X, Article 1, Division 5 of the San Diego Municipal Code.
