AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY APPROPRIATING THE SUM OF \$779,000 GENERAL FUND UNAPPROPRIATED REVENUE TO THE GENERAL FUND NONDEPARTMENTAL EXPENDITURES, TAX ANTICIPATION NOTE PROGRAM 60115, TO COVER COST OF INTEREST EXPENSE, BOND COUNSEL, PAYING AGENT, ADVERTISING AND MISCELLANEOUS EXPENSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 766809 as amended by Document No. 766810, as adopted and amended therein, by appropriating the sum of \$779,000 General Fund Unappropriated Revenue to the General Fund Nondepartmental Expenditures, Tax Anticipation Note Program 60115, to cover the cost of interest expense, bond counsel, paying agent, advertising and miscellaneous expenses.

Section 2. This ordinance is declared to take effect immediately upon its passage, pursuant to the authority contained in Section 17 of the Charter of The City of San Diego.
