AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 1, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 81.11, PROHIBITING FOOD OR BEVERAGE ON ANY VEHICLE OPERATED AS COMMON CARRIER.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 1, of the San Diego Municipal Code be and the same is hereby amended by adding Section 81.11, to read as follows:

SEC. 81.11 FOOD AND BEVERAGE PROHIBITED ON ANY VEHICLE OPERATED AS COMMON CARRIER

It shall be unlawful to consume any food or beverage on any vehicle operated as a common carrier by the San Diego Transit Corporation or the San Diego Metropolitan Transportation Development Board or any successor in interest.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
