
AN ORDINANCE EXTENDING THE EFFECT OF THE  
SAN DIEGO MUNICIPAL CODE SECTIONS 22.0209  
AND 22.0210.1 RELATING TO PUBLIC WORKS  
CONTRACTS FOR ANOTHER YEAR.

BE IT ORDAINED, by the Council of the City of San Diego,  
as follows:

Section 1. That Ordinance No. 12526 (N.S.) amending  
Sections 22.0209 and 22.0210.1 of the San Diego Municipal Code  
be and the same is hereby extended for another year from the  
expiration date thereof.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage and remain  
in effect for one year from the expiration date of Ordinance  
No. 12526 (N.S.) or until January 17, 1981.

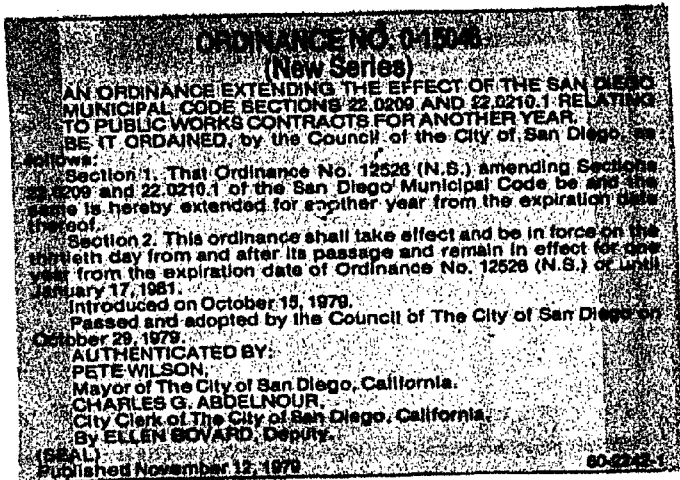
