AN ORDINANCE AMENDING ORDINANCE NO. 12700 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AMENDING DOCUMENT NO. 766809, AS ADOPTED AND AMENDED THEREIN, BY ADDING 1.00 COUNCIL REPRESENTATIVE II POSITION TO THE EXECUTIVE SERVICE DEPARTMENT (01.11); AND AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$15,304 FROM THE UNALLOCATED RESERVE TO THE EXECUTIVE SERVICE DEPARTMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 12700 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR FISCAL YEAR 1979-80 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby further amended by amending Document No. 766809, as adopted and amended therein, by adding 1.00 Council Representative II position to the Executive Service Department (01.11).

Section 2. That the expenditure and transfer of the sum of \$15,304 from the General Fund Unallocated Reserve to the Executive Service Department (01.11), is hereby authorized.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.




