AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2,  
DIVISION 2 OF THE SAN DIEGO MUNICIPAL CODE  
BY AMENDING SECTION 22.0209 RELATING TO  
PUBLIC WORKS CONTRACTS.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That Chapter II, Article 2, Division 2 of the  
San Diego Municipal Code be and it is hereby amended by amending  
Section 22.0209 to read as follows:

SEC. 22.0209 ALTERATIONS IN CONTRACTS

Whenever it becomes necessary to make alterations in  
contracts entered into by the City, the City Manager shall  
make alterations only when authorized by the Council  
unless such alterations meet all of the following criteria.

a. The cost of each such alteration is less than  
\$15,000; and


b. The cost of such alterations does not exceed the  
total amount authorized for the project by ordinance or  
resolution; and

c. It is the opinion of the City Manager that the  
alterations are necessary to fulfill the purpose of the  
contract; and

d. The alterations are made by agreement in writing  
between the contractor and the City Manager.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage and remain in effect for one year from the expiration date of Ordinance No. 12526(N.S.) or until January 17, 1981.
