AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN LANDS IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "SOUTH BAY TERRACES COMMUNITY PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel 2 of Parcel Map No. 4946 located northwesterly of the intersection of Alta View Drive and Casey Street, which is more particularly described in Exhibit A hereto which is by this reference incorporated herein, is hereby set aside and dedicated in perpetuity for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named SOUTH BAY TERRACES COMMUNITY PARK.

Section 3. That the City Clerk of said City be and he is hereby authorized and directed to file for record in the office of the San Diego County Recorder a certified copy of this ordinance.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
