AN ORDINANCE INCORPORATING 23.17 ACRES GENERALLY BOUNDED ON THE NORTH BY STARLING DRIVE AND JUVENILE HALL, ON THE EAST BY I-805, ON THE SOUTH BY MOCKINGBIRD DRIVE, AND ON THE WEST BY CARDINAL ROAD, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 23.17 acres generally bounded on the north by Starling Drive and Juvenile Hall, on the east by I-805, on the south by Mockingbird Drive, and on the west by Cardinal Road, in the Serra Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. C-646.1, be, and it is hereby incorporated into R-2A Zones, as such zones are described and defined by Sections 101.0410 of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:
