AN ORDINANCE INCORPORATING 77.14 ACRES GENERALLY BOUNDED ON THE NORTH BY HURLBUT STREET, ON THE EAST BY GREYLING DRIVE, ON THE SOUTH BY LARKDALE AVENUE, AND ON THE WEST BY KEARNY VILLA ROAD, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 ZONE, AS DEFINED BY SECTION 101.0409 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 5178 (NEW SERIES), ADOPTED MAY 8, 1952, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 77.14 acres generally bounded on the north by Hurlbut Street, on the east by Greyling Drive, on the south by Larkdale Avenue, and on the west by Kearny Villa Road, in the Serra Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2" on Zone Map Drawing No. C-647, be, and it is hereby incorporated into R-2 Zone, as such zone is described and defined by Section 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 5178 (New Series), adopted May 8, 1952, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as the conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
