AN ORDINANCE INCORPORATING 170.46 ACRES GENERALLY LOCATED SOUTH OF GRAMERCY DRIVE AND EXTENDING SOUTH TO THE SAND AND GRAVEL OPERATIONS BORDERING MISSION VALLEY, IN THE SERRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 AND R-1-20 ZONES, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 170.46 acres generally located south of Gramercy Drive and extending south to the Sand and Gravel Operations bordering Mission Valley, in the Serra Mesa Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-1-40" and "R-1-20" on Zone Map Drawing No. C-648.2, be, and it is hereby incorporated into R-1-40 and R-1-20 Zones, as such zones are described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:
