AN ORDINANCE INCORPORATING 3.3 ACRES GENERALLY BOUNDED ON THE NORTH BY "L" STREET, ON THE EAST BY HIGHWAY 15, ON THE SOUTH BY GILLETTE STREET AND ON THE WEST BY 32ND STREET, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B AND R-3 ZONES, AS DEFINED BY SECTIONS 101.0435.2 AND 101.0411, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 3.3 acres generally bounded on the north by "L" Street, on the east by Highway 15, on the south by Gillette Street and on the west by 32nd Street, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "M-1B" and "R-3" on Zone Map Drawing No. C-650.3, be, and it is hereby incorporated into M-1B and R-3 Zones, as such zones are described and defined by Sections 101.0435.2 and 101.0411, respectively, of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, Be, and the same are hereby repealed insofar as they conflict herewith:


