AN ORDINANCE INCORPORATING 26 ACRES GENERALLY BOUNDED ON THE NORTH BY LOGAN AVENUE, ON THE EAST BY 33RD STREET, ON THE SOUTH AND THE WEST BY INTERSTATE 5, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B, CC AND R-2 ZONES AS DEFINED BY SECTIONS 101.0435.2, 101.0427, AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13216, APPROVED MAY 18, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That 26 acres generally bounded on the north by Logan Avenue, on the east by 33rd Street, on the south and the west by Interstate 5, in the Southeast San Diego Community Plan Area, in the City of San Diego, California within the boundary of the district designated "M-1B," "CC," and "R-2" on Zone Map Drawing No. C-650.3, be, and it is hereby incorporated into M-1B, CC, and R-2 Zones, as such zones are described and defined by Sections 101.0435.2, 101.0427, and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 13216, approved May 18, 1931, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions

of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
