AN ORDINANCE INCORPORATING 5.1 ACRES LOCATED ON THE SOUTH SIDE OF IMPERIAL AVENUE BETWEEN 35TH AND 43RD STREETS, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1A, CC AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0436, 101.0427 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 5.1 acres located on the south side of Imperial Avenue between 35th and 43rd Streets, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "M-lA," "CC," and "R-2" on Zone Map Drawing No. C-651.2, be, and it is hereby incorporated into M-lA, CC and R-2 Zones, as such zones are described and defined by Sections 101.0436, 101.0427 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:
