AN ORDINANCE INCORPORATING 7 ACRES BETWEEN 35TH AND 39TH STREETS, NORTH AND SOUTH OF OCEANVIEW BOULEVARD, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CC AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0427 AND 101.0409, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13216, APPROVED MAY 18, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 7 acres between 35th and 39th Streets, north and south of Oceanview Boulevard, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "C" and "R-2" on Zone Map Drawing No. C-651.2 be, and it is hereby incorporated into CC and R-2 Zones, as such zones are described and defined by Sections 101.0427 and 101.0409 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13216, approved May 18, 1931, of the ordinances of the City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
