

AN ORDINANCE INCORPORATING 8 ACRES LOCATED ON THE NORTH BY LOGAN AVENUE, ON THE EAST BY 40TH STREET, ON THE SOUTH BY NEWTON AVENUE, AND ON THE WEST BY HIGHWAY 15, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13216, APPROVED MAY 18, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH. DEC 3 1979

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That 8 acres located on the north by Logan Avenue, on the east by 40th Street, on the south by Newton Avenue, and on the west by Highway 15, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-651.2, be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13216, approved May 18, 1931, of the ordinances of The City of San Diego, be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development or business licenses for uses inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance and such development and/or use is consistent with the provisions of the land use zone applicable to the property prior to the adoption of the emergency rezoning of the area.
