

AN ORDINANCE INCORPORATING 13 ACRES LOCATED BETWEEN LOGAN AVENUE AND DIVISION STREET, WEST AND EAST OF 43RD STREET, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5, CC AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0407, 101.0427 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:


Section 1. That 13 acres located between Logan Avenue and Division Street, west and east of 43rd Street, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-1-5," "CC" and "R-2" on Zone Map Drawing No. C-651.2, be, and it is hereby incorporated into R-1-5, CC and R-2 Zones, as such zones are described and defined by Sections 101.0407, 101.0427 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:

This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
