AN ORDINANCE INCORPORATING 3.2 ACRES LOCATED BETWEEN 45TH AND 49TH STREETS, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CC AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0427 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 3.2 acres located between 45th and 49th Streets, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CC" and "R-2" on Zone Map Drawing No. C-652.2, be, and it is hereby incorporated into CC and R-2 Zones, as such zones are described and defined by Sections 101.0427 and 101.0409, respectively, of the San Diego Municipal Code.
