AN ORDINANCE INCORPORATING 5.1 ACRES LOCATED BETWEEN 50TH STREET AND EUCLID AVENUE, NORTH OF IMPERIAL AVENUE, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO CC ZONE, AS DEFINED BY SECTION 101.0427 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 78 (NEW SERIES), ADOPTED NOVEMBER 14, 1932, AND ORDINANCE NO. 116 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. That 5.1 acres located between 50th Street and Euclid Avenue, north of Imperial Avenue, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CC" on Zone Map Drawing No. C-652.2, be, and it is hereby incorporated into CC Zone, as such zone is described and defined by Section 101.0427 of the San Diego Municipal Code.

Section 2. That Ordinance No. 78 (New Series), adopted November 14, 1932, and Ordinance No. 116 (New Series), adopted January 3, 1933, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
