AN ORDINANCE AMENDING ORDINANCE NO. 12666 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR FISCAL YEAR 1979-80," BY AMENDING EXHIBITS A AND B THERETO TO CREATE THE CLASSIFIED POSITIONS OF BUILDING INSPECTION TECHNICIAN I, BUILDING INSPECTION TECHNICIAN II AND BUILDING INSPECTION TECHNICIAN III, AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 12666 (New Series), as amended, entitled, "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1979-80," is hereby amended to create and establish the classified positions of Building Inspection Technician I, Building Inspection Technician II and Building Inspection Technician III.

Section 2. As a schedule of compensation for the positions created in Section 1 hereof, the following standard rate numbers of the Table of Pay for Standard Rates established and adopted by Ordinance No. 12666 (New Series), as amended, of the ordinances of said City, is hereby adopted:



Section 3. The positions of Building Inspection Technician I, Building Inspection Technician II and Building Inspection Technician III shall be inserted in Exhibit B of Ordinance No. 12666 (New Series), as amended, under the proper categories.

Section 4. The Auditor and Comptroller is hereby directed to amend as necessary Exhibit A of Ordinance No. 12666 (New Series), as amended, by calculating and inserting in said Table of Pay for Standard Rates the new rates attached hereto as Exhibit 1 with the salary ranges indicated.

Section 5. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
