AN ORDINANCE SETTING ASIDE AND DEDICATING

and recreational purposes.


Section 2. That the hereinafter described real pro-
perty be and the same is hereby named DEL GARDENS PARK.

Section 3. That the City Clerk of said City be and

in the office of the San Diego County Recorder a certified
copy of this ordinance.

Section 4. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
