AN ORDINANCE AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT WITH THE SAN DIEGO UNIFIED SCHOOL DISTRICT FOR THE PURPOSE OF LEASE, DEVELOPMENT AND MAINTENANCE OF PORTIONS OF THE CADMAN ELEMENTARY SCHOOL, ALCOTT ELEMENTARY SCHOOL, JUAREZ ELEMENTARY SCHOOL AND LEWIS JUNIOR HIGH SCHOOL SITES.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the SAN DIEGO UNIFIED SCHOOL DISTRICT for the purpose of lease and maintenance of a portion of the Cadman Elementary School site and for the lease, development and maintenance of portions of the Alcott and Juarez Elementary School sites and a portion of the Lewis Junior High School site, for a term of 25 years, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No.

00-15131.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
