AN ORDINANCE INCORPORATING 33 ACRES GENERALLY BOUNDED ON THE NORTH BY COMMERCIAL AVENUE, ON THE EAST BY HIGHWAY 15, ON THE SOUTH BY VALLE AND HARRISON AVENUES, AND ON THE WEST BY CROSBY STREET, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A AND CC ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0437, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING CERTAIN ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 33 acres generally bounded on the north by Commercial Avenue, on the east by Highway 15, on the south by Valle and Harrison Avenues, and on the west by Crosby Street, in the Southeast San Diego Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "R-2A" and "CC" on Zone Map Drawing No. C-650.3, be, and it is hereby incorporated into R-2A and CC Zones, as such zones are described and defined by Sections 101.0410 and 101.0427, respectively, of the San Diego Municipal Code.

Section 2. That the following ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith:
