Section 1. That Chapter VI, Article 1, Division 5, of the San Diego Municipal Code be and the same is hereby amended by amending Section 61.0505 to read as follows:

SEC. 61.0505 EXCEPTIONS

Unless otherwise provided in the resolution creating the District, this ordinance and any resolution adopted pursuant thereto shall not apply to the following types of facilities:

(j) Poles, supports, wires and associated overhead structures used exclusively for supplying power to electrically driven mass transit vehicles.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
