AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 35, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.3513(r), RELATING TO THE REGULATION OF MASSAGE BUSINESS AND MASSAGE TECHNICIANS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 35, of the San Diego Municipal Code be and the same is hereby amended by amending Section 33.3513(r), to read as follows:

SEC. 33.3513 MASSAGE ESTABLISHMENTS--OPERATING REQUIREMENTS

Subsections (a) through (q) remain the same.

(r) With the exception of bathrooms, showers and dressing rooms, no owner, operator, responsible managing employee, manager, or permittee in charge of or in control of any massage establishment shall permit any person in any area within the massage establishment which is used by the patrons or which can be viewed by patrons from such an area, unless the person's specified anatomical areas are fully covered.

Subsections (s) and (t) remain the same.

Section 2. This ordinance shall take effect and be in force on the thirtieth dam from and after its passage.
